How To Fill Out the Direct Registration (DRS) Transaction Request Form

To enter certificates into your Direct Registration book entry position: Check the "Deposit" box below and mail your certificates with the Transaction Request Form to Computershare, Attn: Securities Transfer Department, 100 University Ave, 8th Floor, Toronto Ontario, M5J 2Y1. When sending certificates through the mail, we recommend the use of registered or certified mail. Do not endorse the certificates. A DRS Advice will be issued and mailed to the address of record.

TO ELECTRONICALLY TRANSFER YOUR SECURITIES TO YOUR BROKER

If you wish to move securities from your DRS book entry position to your broker, your broker will require the following information from you to successfully complete this request:

- 1) A copy of your latest advice
- 2) Your Holder Account Number at Computershare (which can be found on your advice)
- 3) Your tax identification/social insurance number
- 4) Quantity of Unrestricted Securities in your DRS account at Computershare.

Your broker will send an electronic message to Computershare, who in turn will electronically transfer your book entry position to your broker.
