


Computershare Registration Instructions

Read These Instructions Before You Get Started

Before you get started, you will need access to your email. There are three simple steps to create a User ID for Investor Center:

- 1) Confirm your stock - Select a stock from drop down
- 2) User Registration - Set up login credentials
- 3) Confirm your email - Verify Your Email Address

*At this step, you must select either the button that says I have confirmed my email OR Confirm Later.

Do Not close any window or tab until you have clicked on the link in your email and have reached the Email Confirmation screen.

Select one of the two options below to register:

Option 1 – Social Security Number

This option is available for 1) US residents with a US tax ID number OR 2) Business accounts or entity accounts (These types of accounts should enter the EIN of the company.)

Immediate Online Access: If you choose this option, you should receive immediate access if you pass an online identity verification process.

Option 2 – Holder Account Number

This option is for those who live outside the United States or those who do not wish to use their social security number only.

Up to 2 weeks: If you choose this option you may need to have a verification process sent to you via postal mail - it can take up to 2 weeks to receive this.


